Dear All City Council Members,

The membership of the Triple Crown Estates Homeowners Association met today and discussed the lift station that is currently owned and managed by our association. We have been told that we can extend our pipes and feed into the sewer system when it is extended down Railroad to accommodate new developments north of us on the other side of the tracks. We do manage the current lift station to the best of our ability, but the chance we can rally that kind of funds without help is improbable.

Per our CCR anything that affects our common area ownership, including the lift station would require a vote of at least 67% of our membership to vote in favor. We have collected enough votes from our membership to comply with this requirement. Our membership is requesting that the Nampa City Council vote in favor of forming a Local Improvement District (LID) to fund a project that would allow the sewer lines to be connected to the main system and allow our lift station to be decommissioned. Thank you for your consideration of this important issue.
