Nampa Golf Season Pass Policy

Ridgecrest Golf Club and Centennial Golf Course are divisions of the City of Nampa Parks and Recreation Department. A limited number of Season Passes and City Discount Cards will be sold each year. Season Passes are valid starting on January 1st of each year and expire on December 31st. All Season Passes (except Centennial Grandfathered Passes) are 7 Day Restricted passes, valid Monday through Friday, except holidays, and after 12pm on Saturday, Sunday, and holidays.

Ridgecrest Golf Club:

- Individual Season Passes are valid Monday – Friday anytime. Pass is restricted on Saturday, Sunday, and Holidays until 12:00pm. This restriction is from March 1 – September 30.
- To have the opportunity to play during restricted times, a pass holder MUST bring 3 paying customers to play for no charge during restricted times.
- Individual Season Passes are valid on the Wee 9 during golf course operating hours.
- Wee 9 Adult & Wee 9 Junior pass is valid during all golf course operating hours.

Centennial Golf Course:

- Individual Season Passes are valid Monday – Friday during operating hours. Pass is restricted on Saturday, Sunday, and Holidays until 12:00pm. This restriction is from March 1 – September 30.
- To have the opportunity to play during restricted times, a pass holder MUST bring 3 paying customers to play for no charge during restricted times.
- Grandfathered 5 Day Pass are valid Monday – Friday during golf course operating hours. Pass does NOT include any holidays that occur Monday – Friday.

Ridgecrest/Centennial City Pass:

- Ridgecrest/Centennial City Passes are valid Monday – Friday during golf course operating hours. Pass is restricted on Saturday, Sunday, and Holidays until 12:00pm. This restriction is from March 1 – September 30.
- To have the opportunity to play during restricted times, a pass holder MUST bring 3 paying customers to play for no charge during restricted times.
- The City Pass is valid on Wee 9 during golf course operating hours.

If the maximum number of passes sold has been reached, no additional passes will be sold. Previous year Passholders will have first opportunity to renew their Season Pass for the upcoming year. Season Passes are available to purchase for returning Pass Holders beginning December 1st (or sooner if determined by staff) through December 31st for the next golf season. If additional passes are available, they will be sold on a first-come basis beginning on January 2nd of each year. All Season Passes are non-refundable and subject to price increases.

Change in Policy

Nampa Golf Tee Time Reservation Policy

It is the goal of Nampa Golf to provide a high-quality experience at the Nampa City Golf Courses. It has been our practice to require tee times for the championship courses at Ridgecrest and Centennial Golf Course.

Beginning January 2, 2025, the Ridgecrest Wee 9 Course will begin taking tee times. Prior to January 2, 2025 the Wee 9 course was “walk on only.” This change to take tee times is due to the increase in play. The goal is to improve the pace of play and improve each player’s experience.

Tee Time Booking Policy:

- Tee times will be taken in person, over the phone, or via online website seven (7) days in advance. Centennial Championship Golf Course, the Ridgecrest Championship Golf Club and the Ridgecrest Wee 9 take tee times.
- No single player bookings allowed; singles will be put on waitlist and assigned a tee time when space determined.
- A maximum of three (3) tee times may be booked for each day to any person or group.
- Season Pass holders must abide by restrictions on weekends and holidays March 1 – September 30 of the calendar year.



HARWARD RECREATION CENTER MEMBERSHIP ELIGIBILITY

OVERVIEW

Anyone is eligible to purchase an individual membership to the Harward Recreation Center regardless of City of Nampa residency. However, to be eligible for a Harward Recreation Center family membership or senior couple membership the primary member and spouse must be legally married as recognized by the state of Idaho. In addition, only children considered legal dependents ages 18 and under may be included on a family membership. Provisions may be made to place dependent children ages 19 through 21 on a family membership.

DEPENDENT EXTENSIONS

By providing acceptable proof of dependency, a dependent extension allows a primary member to include dependent children ages 19 through 21 years of age on a Harward Recreation Center family membership. Children older than 21 years of age do not qualify to be secondary members on a family membership and will have to purchase an individual membership.

PROOF OF MARRIAGE AND/OR DEPENDENCY

At the time of membership purchase or at any time during an active membership period, the HRC reserves the right to ask for documentation illustrating the proof of age, marriage and/or dependency.

Below is a list of items that members or membership applicants may be asked to provide. In some cases, other forms of verification may be accepted upon HRC administrative review.

- Signature on the HRC Membership Waiver verifying the primary applicant is legally married to a spouse.
- Signature on the HRC Membership Waiver verifying secondary children listed on the application are legal dependents of the primary applicant.
- Members or membership applicants may be asked to provide a marriage certificate as proof of marriage.
- Members or membership applicants may be asked to provide a birth certificate for dependent children.
- Members or membership applicants may be asked to provide current 1040 tax forms to verify dependency.

- Members or membership applicants may be asked to provide adoption records, court placement records, and/or other custody/guardianship documents as accepted by HRC administration.

SENIOR MEMBERSHIPS

Individuals may purchase the HRC senior membership when they turn 65 years of age. Couples are eligible for the senior couple membership when one spouse turns 65 years of age. However, anyone claiming dependents on their membership must maintain a family membership regardless of the primary member's age.

MEMBERSHIP MEDICAL HOLDS

As a courtesy, a member may request their membership to be placed on "hold" due to a medical restriction. Supporting documentation from a physician will be required. Only 1 hold will be granted per membership year. Hold(s) cannot exceed 12 months over that membership term.



HARWARD RECREATION CENTER ANNUAL MEMBERSHIP FEE STRUCTURE

STATEMENT OF PURPOSE

This fee structure provides an understanding of Harward Recreation Center annual memberships, explains rates and payment options, and defines who can be included on the different membership options.

PHILOSOPHY OF ANNUAL MEMBERSHIPS

Annual memberships to the Harward Recreation Center are available to purchase for anyone. The Harward Recreation Center does not discriminate against anyone regardless of sex, race, religion or sexual orientation. City of Nampa residency is not required for membership.

The purchase of an annual membership gives the holder(s) admittance to the Harward Recreation Center for one year, during regular business hours, from the date of activation. Some pre-scheduled dates where the NRC facility will be closed include, Christmas, Easter and during a facility maintenance period once per year. Any unexpected and/or necessary facility closures may occur infrequently and will be announced in advance when possible.

Annual members have access to amenities and services deemed “included” with an annual membership. However, not all amenities and services provided at the NRC location are included with the purchase of an annual membership and additional fees may apply. Most programs and services offered at the NRC will offer a discounted membership rate for annual members.

RATES AND RENEWAL

Annual memberships may be purchased only at the Harward Recreation Center during normal business hours. Membership rates are subject to periodic increases and may increase with or without notice. Annual memberships will not be sold on a pro-rated basis. Membership options are available in the following categories:

- Family –
 - Legally married couple as recognized by the State of Idaho, or
 - Legally married couple as recognized by the State of Idaho plus their dependent children, or
 - Individual plus their dependent children.

- See eligibility guidelines for details.
- Individual – One person between the ages of 18 and 64.
- Youth Individual – One person aged 17 years or younger.
- Senior Individual – One person aged 65 years or older.
- Senior Couple – Legally married couple as recognized by the State of Idaho where at least one individual is aged 65 years or older.

Annual members may transition, at time of renewal, to the senior membership when they turn 65 years of age. Couples are eligible for the senior couple membership when one spouse turns 65 years of age. However, anyone claiming dependents on their membership must maintain a family membership regardless of the primary member's age.

No refunds will be given in the event a family membership is converted to an individual membership during the course of a membership year. All annual memberships are non-refundable.

REFUNDS / CANCELATIONS

Annual memberships expire one year from the purchase date. Memberships will not be refunded due to moving, divorce, illness, death or any other reason. If it is found that a member falsified membership eligibility information that membership may be revoked without refund.

Memberships cannot be suspended for reasons aside from medical necessity or military deployment. Supporting documentation must be provided from a doctor or military office in order for a membership suspension to be granted.

PAYMENT DRAFT CONTRACTS

Harward Recreation Center annual memberships may be paid in full or a payment plan draft contract may be established. All NRC payment draft contracts obligate the purchaser to a minimum of a one year membership. The Harward Recreation Center will collect the balance owed on defaulted contracts.

Terms, conditions and additional fees apply to a payment draft contract. See the NRC front desk for specific obligations and fees. Annual members using the payment plan are entitled to the same amenities as members who pay in full.

INSURANCE MEMBERSHIP PLANS

It is recognized that many insurance providers offer a variety of options that may include a "gym membership" with participating facilities as part of their health or supplemental Medicare Insurance Plans. As policy, Nampa's recreation center does not enter into contractual agreements or give preference to any particular insurance company concerning membership pricing for their clients. The only agreement recognized is

between the Harward Recreation Center and the individual that has purchased a service or a membership type.

The Harward Recreation Center will provide a receipt or proof of purchase that may allow an insurance company to reimburse patrons directly according to the patron's insurance plan.

DEFINITION OF DEPENDENTS

The primary member and spouse must be legally married as recognized by the state of Idaho to be eligible for a family or senior couple membership. In addition, only children considered legal dependents ages 18 and under may be included on a family membership. Provisions may be made to place dependent children ages 19 through 21 on a family membership.

At the time of membership purchase or at any time during an active membership period, the NRC reserves the right to ask for documentation illustrating the proof of age, marriage and/or dependency.

Below is a list of items that members or membership applicants may be asked to provide. In some cases, other forms of verification may be accepted upon NRC administrative review.

- Signature on the NRC Membership Application verifying the primary applicant is legally married as recognized by the State of Idaho to a spouse.
- Signature on the NRC Membership Application verifying secondary children listed on the application are legal dependents of the primary applicant.
- Members or membership applicants may be asked to provide a marriage certificate as proof of marriage.
- Members or membership applicants may be asked to provide a birth certificate for dependent children.
- Members or membership applicants may be asked to provide current 1040 tax forms to verify dependency.
- Members or membership applicants may be asked to provide adoption records, court placement records, and/or other custody/guardianship documents as accepted by NRC administration.



HARVARD RECREATION CENTER CHARTER MEMBERSHIP FEE STRUCTURE

STATEMENT OF PURPOSE

The charter membership fee structure creates an understanding of charter memberships, explains the process of maintaining charter memberships, and outlines who is eligible for charter membership status.

PHILOSOPHY OF CHARTER MEMBERSHIPS

Harvard Recreation Center (HRC) charter members are an exclusive group who purchased memberships prior to the Harvard Recreation Center opening in April of 1994. The charter membership was created to raise the capital dollars needed to start construction. Charter members must continue to maintain their membership each year in order to maintain the charter benefits. Charter memberships were only sold prior to April 1994 and are no longer available for purchase.

All charter membership fees must be paid in full on or before May 1st of each year. Payment plans are not accepted for charter membership payment. Charter membership rates are subject to increase each year.

CHARTER STATUS AND RENEWAL

Annual charter membership fees are due by May 1st of each year. Annual renewal of charter memberships is necessary to maintain charter status. If a charter member fails to renew by the May 1st deadline, charter status is voided. If charter membership is lost, an option is available to purchase an annual membership at the current advertised value.

Members who have lost their charter status may contact the HRC Membership Coordinator to inquire about reinstatement.

- The HRC Membership Coordinator will evaluate eligibility. Only original charter members may re-gain charter status.
- All outstanding charter membership fees for past years left unpaid will be determined at current membership rates.
- If necessary, a payment contract may be drafted to fulfill outstanding fees prior to reinstatement of charter status.

No refunds will be given in the event a family charter membership is converted to an individual charter membership during the course of a membership year. Charter memberships are non-transferable and expire upon the membership not being renewed or with the death of the member.

Charter members may transition, at time of renewal, to the charter senior membership when they turn 65 years of age. Couples are eligible for the senior couple membership when one spouse turns 65 years of age. However, anyone claiming dependents on their membership must maintain a charter family membership regardless of the primary member's age.

DEFINITION OF DEPENDENTS

To be eligible for a charter family membership or charter senior couple membership the primary member and spouse must be legally married as recognized by the state of Idaho. In addition, only children considered legal dependents ages 18 and under may be included on a family membership. Provisions may be made to place dependent children ages 19 through 21 on a family membership.

At the time of membership purchase or at any time during an active membership period, the HRC reserves the right to ask for documentation illustrating the proof of age, marriage and/or dependency.

Below is a list of items that members or membership applicants may be asked to provide. In some cases, other forms of verification may be accepted upon HRC administrative review.

- Signature on the HRC Membership Application verifying the primary applicant is legally married as recognized by the State of Idaho to a spouse.
- Signature on the HRC Membership Application verifying secondary children listed on the application are legal dependents of the primary applicant.
- Members or membership applicants may be asked to provide a marriage certificate as proof of marriage.
- Members or membership applicants may be asked to provide a birth certificate for dependent children.
- Members or membership applicants may be asked to provide current 1040 tax forms to verify dependency.

- Members or membership applicants may be asked to provide adoption records, court placement records, and/or other custody/guardianship documents as accepted by HRC administration.

CHARTER BREAK-OFFS

Dependent children of original charter members may “break-off” from their parent’s charter membership and retain their charter status. They must “break-off” when they turn 19 years of age or are no longer eligible to be included on their parent’s charter membership. If they fail to “break-off” at time of renewal, they will lose their charter status. All requirements for original charter members apply to newly created “break-off” charter memberships. “Break-off” charter memberships are only allowed for one generation from the original purchaser of a charter membership. Otherwise, charter memberships are not transferable.

In the event of legal divorce between two original family charter members, both parties may retain charter status. Spouses added to original charter memberships cannot “break-off” and will lose charter status upon divorce or death of the original charter member.



HARVARD RECREATION CENTER MONTHLY MEMBERSHIP FEE STRUCTURE

STATEMENT OF PURPOSE

This fee structure provides an understanding of Harvard Recreation Center monthly memberships, explains rates and cancelations, and defines who can be included on the different membership options.

PHILOSOPHY OF MONTHLY MEMBERSHIPS

Monthly memberships to the Harvard Recreation Center are available to purchase for anyone. The Harvard Recreation Center does not discriminate against any individual due to, but not limited to physical abilities, gender, race, religion or sexual orientation. City of Nampa residency is not required for membership.

The purchase of a monthly membership gives the holder(s) admittance to the Harvard Recreation Center on a monthly basis, during regular business hours. from the date of activation. Some pre-scheduled dates where the HRC facility will be closed include, Christmas, Easter and during a facility maintenance period once per year. Any unexpected and/or necessary facility closures may occur infrequently due to maintenance issues or public health concerns and will be announced in advance when possible.

Monthly members have access to amenities and services deemed “included” with a HRC membership. However, not all amenities and services provided at the HRC location are included with the purchase of a monthly membership and additional fees may apply. Most programs and services offered at the HRC will offer a discounted membership rate for members.

RATES AND RENEWAL

Monthly memberships may be purchased only at the Harward Recreation Center during normal business hours. Membership rates are subject to periodic increases and may increase with or without notice. Membership options are available in the following categories:

- Family –
 - Legally married couple as recognized by the State of Idaho, or
 - Legally married couple as recognized by the State of Idaho plus their dependent children, or
 - Individual plus their dependent children.
 - See eligibility guidelines for details.
- Individual – One person between the ages of 18 and 64.
- Youth Individual – One person aged 17 years or younger.
- Senior Individual – One person aged 65 years or older.
- Senior Couple – Legally married couple as recognized by the State of Idaho where at least one individual is aged 65 years or older.

Monthly members may transition to the senior membership the month following when they turn 65 years of age. Couples are eligible for the senior couple membership when one spouse turns 65 years of age. However, anyone claiming dependents on their membership must maintain a family membership regardless of the primary member's age. Youth membership may be reviewed every year to verify age. In the event the member turns 18 years of age, the membership fee will increase.

No refunds will be given in the event a family membership is converted to an individual membership during the course of the membership. All memberships are non-refundable.

REFUNDS / CANCELATIONS

Monthly memberships do not expire until written cancellation is received. Any changes to your account or membership must be made 5 days prior to draft date. Memberships will not be refunded due to moving, divorce, illness, or any other reason. If it is found that a member falsified membership eligibility information that membership may be revoked without refund.

Memberships cannot be suspended for reasons aside from medical necessity or military deployment. Supporting documentation must be provided from a doctor or military office in order for a membership suspension to be granted.

DEFINITION OF DEPENDENTS

The primary member and spouse must be legally married as recognized by the state of Idaho to be eligible for a family or senior couple membership. In addition, only children considered legal dependents ages 18 and under may be included on a family membership. Provisions may be made to place dependent children ages 19 through 21 on a family membership.

At the time of membership purchase or at any time during an active membership period, the HRC reserves the right to ask for documentation illustrating the proof of age, marriage and/or dependency.

HARWARD RECREATION CENTER DAY PASS FEE STRUCTURE

OVERVIEW

Day passes may be purchased for admittance to the Harward Recreation Center regardless of City of Nampa residency. Day passes do not give the customer all the advantages that an annual membership provides. The purchase of a day pass does not allow discounting on programs and does not include complimentary personal training sessions. However, program discount and complimentary personal training privileges are received with an annual membership purchase.

DURATION

Harward Recreation Center day passes are valid for one day during regular business hours. The purchase of a day pass allows for return admittances for the purchaser throughout that day's normal business hours. A date stamp on the hand or a re-admittance slip is required prior to leaving the facility for later re-admittance. Typically, day passes are utilized the day of purchase. However, pre-paid day passes are available for purchase at the normal day pass rates.

GROUP DISCOUNTS

Discounted rates are available to groups and organizations purchasing day passes in quantities of 25 or more. Discounts are also available to customers who have rented the birthday party room. All groups and organizations must contact the Harward Recreation Center in advance to schedule a visit date and time.

- **NON-PROFIT & SERVICE GROUP DISCOUNTS**

Non-profit and human service organizations may qualify for discounted Harward Recreation Center day passes depending on the scope of their mission. Qualifying organizations must order and pre-pay for a minimum of 25 day passes at a time. Contact Harward Recreation Center administration for approval and to place day pass orders.



HARWARD RECREATION CENTER LIFETIME MEMBERSHIP FEE STRUCTURE

STATEMENT OF PURPOSE

This fee structure provides an understanding of Harward Recreation Center lifetime memberships, explains rates and payment options, and defines who can be included on lifetime memberships.

PHILOSOPHY OF LIFETIME MEMBERSHIPS

Lifetime memberships to the Harward Recreation Center are available to purchase for anyone. The Harward Recreation Center does not discriminate against anyone regardless of sex, race, religion or sexual orientation. City of Nampa residency is not required for membership.

The purchase of a lifetime membership gives the holder(s) admittance to the Harward Recreation Center for the duration of their lives, during regular business hours, from the date of activation. Some pre-scheduled dates where the HRC facility will be closed include, Christmas, Easter and during a facility maintenance period once per year. Any unexpected and/or necessary facility closures may occur infrequently and will be announced in advance when possible.

Lifetime members have access to amenities and services deemed “included” with a lifetime membership. However, not all amenities and services provided at the HRC location are included with the purchase of a lifetime membership and additional fees may apply. Most programs and services offered at the HRC will offer a discounted membership rate for lifetime members. Lifetime members receive free use of the Play Center under current guidelines and policies.

RATES AND RENEWAL

Lifetime memberships may be purchased only at the Harward Recreation Center during normal business hours. Membership rates are subject to periodic increases and may increase with or without notice. Lifetime memberships will be sold on a pro-rated basis based on an applicant's age at the time of purchase. Lifetime membership rates for couples are calculated according to the youngest spouse. Membership options are available in the following categories:

- Couple/Family –
 - Legally married couple as recognized by the State of Idaho, or
 - Legally married couple as recognized by the State of Idaho plus their dependent children, or
 - Individual plus their dependent children.
 - See eligibility guidelines for details.
- Individual – One person regardless of age.

REFUNDS / CANCELLATIONS

Lifetime memberships will not be refunded or transferred to another person due to moving, divorce, illness, death or any other reason. If it is found that a member falsified membership eligibility information, lifetime memberships may be revoked without refund.

PAYMENT DRAFT CONTRACTS

Harward Recreation Center lifetime memberships may be paid in full or a payment plan contact may be established. All HRC payment contracts obligate the purchaser to complete the purchase of a lifetime membership. The Harward Recreation Center will collect the balance owed on defaulted contracts.

Terms, conditions and additional fees may apply to a payment contract. See the HRC Membership Coordinator for specific obligations and fees. Lifetime members using the payment plan are entitled to the same amenities as members who pay in full.

DEFINITION OF DEPENDENTS

The primary member and spouse must be legally married as recognized by the state of Idaho to be eligible for a couple or family lifetime membership. In addition, only children considered legal dependents ages 18 and under may be included on a couple or family lifetime membership. - Signature on the HRC Membership Application verifying the primary applicant is legally married as recognized by the State of Idaho to a spouse.
- Signature on the HRC Membership Application verifying secondary children listed on the application are legal dependents of the primary applicant.
- Members or membership applicants may be asked to provide a marriage certificate as proof of marriage.
- Members or membership applicants may be asked to provide a birth certificate for dependent children.
- Members or membership applicants may be asked to provide current 1040 tax forms to verify dependency.
- Members or membership applicants may be asked to provide adoption records, court placement records, and/or other custody/guardianship documents as accepted by HRC administration.

DIVORCE/DEATH

In the event of a divorce, the lifetime membership may not be transferred or refunded. The couple will become two individual lifetime members. In the event of a re-marriage, the new spouse/step children may purchase their own lifetime membership(s), but will not be included under the previous couple/family lifetime membership.

In the event of death to a spouse, the remaining lifetime member will become an individual lifetime member. If the remaining original lifetime member re-marries, their new spouse may purchase their own lifetime membership, but will not be included under the previous couple/family lifetime membership.



HARWARD RECREATION CENTER PUNCH PASS FEE STRUCTURE

OVERVIEW

Punch passes may be purchased for admittance to the Harward Recreation Center by anyone regardless of City of Nampa residency. Punch passes can be purchased in increments of 20 visits and allows admittances at a discounted rate per visit when compared to day passes. Punch passes give the purchaser access to the same amenities and services of an annual member with the exception of the “member rate” to supplementary programs, i.e. swimming lessons, gymnastics, etc. Punch pass holders receive two free personal training sessions per year.

DURATION

Harward Recreation Center punch passes are valid for three years from the date of purchase or until redeemed. The use of one scan or “punch” on a punch pass allows for return admittances for the user throughout that day’s normal business hours. A date stamp on the hand or a re-admittance slip is required prior to leaving the facility for later re-admittance.

MULTIPLE USERS

Punch passes are unique from other Harward Recreation Center admittance methods because they allow for multiple users as long as subsequent users are within the same age category. Each user of a punch pass must scan or “punch” the pass at the time of the first daily visit.

Kohlerlawn Cemetery

Standard Operating Practices:

Kohlerlawn is Nampa's only municipal cemetery and is managed by a small and dedicated staff under the Parks and Recreation Department. Its storied history of all who are interned there, coupled with its beautiful setting, make it a gem in our community. It is truly a spiritual garden where people can come to remember their loved ones who have been laid to rest.

In order to achieve our mission of protecting, preserving and beautifying Nampa's perpetual care areas while providing compassionate and professional service to Nampa's citizens and visitors, the following operating practices are observed. If you have any questions regarding Kohlerlawn's standard operating practices, please contact our Sexton's office located at the cemetery or visit our website www.nampaparks.org.

Interment:

- Requests for gravesite openings shall be submitted to the Sexton at least twenty-four (24) hours in advance of a funeral during weekdays Monday – Friday, 8:00 am to 5:00 pm.
- Requests for Saturday and Monday openings shall be submitted before 12:00 noon the previous Friday.
- Scheduling of services must be approved by the Sexton to ensure proper time intervals between services. Cemetery staff shall perform all gravesite opening, casket or cremation internments. Family members may assist with closing of gravesites upon Sexton's approval.
- Hours for burial internments will be between 10:00 a.m. – 3:00 p.m. Monday – Friday. No burials shall be scheduled before 10:00 a.m. Burial internments scheduled after 3:00 p.m. arriving at cemetery 4:00 p.m. or later will be charged an additional fee.

Traditional Casket Burials:

- Traditional caskets shall be enclosed in a burial vault made of concrete that meet design criteria established in the National Concrete Burial Vault Association's Performance Standards such as ASTM WK828 or ASTM WK. All burial vaults must be in acceptable condition and will be subject to approval by the Sexton.
- All burial vaults must be purchased from a mortuary company, Kohlerlawn Cemetery does not sell vaults. Cost of vault is not included in cemetery open/close grave fees.
- All burial vaults shall be suspended at or above ground level at time of service. This is to be compliant with confined space entry regulations.

Updated: August 2024

- Gravesites will be opened on the day of service if arrival time is after 11:00 am. For services prior to 11:00 am, gravesites will be opened the previous day.
- For any gravesite requested to be opened the day prior to a service by a private mortuary company, a Wilbert style burial vault is required and shall be set and suspended prior to 5:00 pm the day prior to service upon the Sexton's approval.
- Cemetery staff shall perform all installations and lowering of concrete vaults (other than Wilbert style vaults). This entails transport of vault to gravesite, placement of lowering device, green carpets, chairs and shelter (if needed) at gravesite.
- Wilbert Vaults – a qualified mortuary company is responsible for setting up and lowering Wilbert style vaults. Extra chairs or shelter must be ordered from at time of vault order. Differentiation in fees reflect interment work being performed by private mortuary company staff rather than Kohlerlawn Cemetery staff.

Cremation Burial:

- Cremation interments include opening and closing of gravesite by Kohlerlawn staff.
- Up to five (5) cremation urns can be placed on one adult space.
- Urn vaults are not required for cremation interments but may be used at the discretion of the family interring the urn for burial. Urn vault must be constructed of concrete and purchased from a mortuary company.
- A release form for interment on gravesites must be signed and returned to Kohlerlawn's Cemetery office or the City of Nampa Clerk's office by legal owner or heir prior to interment.

Niche Wall Internment:

- Cremation urns have a maximum size that can fit into the niche wall spaces. All niche wall urns can be no larger than 10 ½ inches in any dimension.
- Engraving forms must be signed and returned to the Kohlerlawn office prior to the niche wall panel being engraved. A maximum of 25 characters are allowed in addition to the name and dates information.
- Open/close and engraving fees must be paid prior to interment.

Disinterment:

- Traditional casket burials – All disinterments must be scheduled through a mortuary company and be approved by the State prior to exhumation. After disinterment, space ownership will automatically revert to the City of Nampa for resale.
- Cremations – Prior to exhumation, all cremation disinterments must be approved and scheduled by cemetery Sexton. A mortuary company's services are not needed but can be requested. If ashes are to be shipped to another location, the person requesting disinterment is responsible for certified mail fees in addition to cemetery disinterment fees. Space ownership will not revert to the City of Nampa if traditional casket burial is previously interred in that space location, or the urn is returned to that original gravesite.

Chairs and Shelters (Excluding Wilbert Vaults):

- Funeral services include six (6) chairs and green carpets around gravesite. Additional chairs, up to twelve (12), may be requested from Sexton at the time of ordering a gravesite opening.
- Shelter rental must be requested by a mortuary company or family and costs an additional fee. Otherwise, shelter set up is at the discretion of cemetery staff due to inclement weather not foreseen at time of scheduling service. Shelter fees must be paid at time of service and cannot be invoiced.

Headstone Monuments and Temporary Markers:

- Cremation urns have a maximum size that can fit into the niche wall spaces. All niche wall urns can be no larger than 10 ½ inches in any dimension.
- Headstone monument specifications are detailed at www.nampaparks.org Any deviation of headstone monument specification not identified on the City's website must receive Sexton's approval.
- Temporary gravesite markers will be supplied by the mortuary company and installed by Kohlerlawn staff.
- Once a headstone monument is set, temporary markers will be removed. City of Nampa is not responsible for replacement or condition of temporary markers.

Decorations:

- Artificial or cut flowers – flowers on gravesites will be removed seven (7) days after placement during mowing season, June – October. Flowers that are out of the way of mowing and trimming (in vases), will be left alone.
- Planting flowers – annual flowers are permitted to be planted behind headstone. Removal of sod (6" minimum) from base of plant.
- Ornamental shrubs – Planting of shrubs are not allowed without Sexton's approval.
- Personal mementos – Personal items are permitted if they rest on the headstone and do not interfere with maintenance of cemetery. Items that blow over or are otherwise displaced will be disposed of. Due to theft, items of monetary value are discouraged. City of Nampa is not responsible for stolen or missing items.
- Windsocks/ banners are not permitted on cemetery grounds.

Fees for Spaces and Services:

- Kohlerlawn Cemetery's fees are reviewed and adopted by Nampa City Council each year. The Sexton or other cemetery staff cannot make alterations to established fees.
- Payment for cost of gravesite spaces may be paid for prior to burial. Open and close fee can only be paid for at time of service.
- Cost of space(s) or open/close fee shall be paid in full, partial payments are not permitted.
- Payments can be made to Kohlerlawn Cemetery office, City Clerk's office or private mortuary service provider who is coordinating with the cemetery on a customer's behalf.
