- ♦ **Renewal** applications are due no later than May 31; Failure to apply on or before the renewal date shall result in the application being considered a "New" application and the fees being doubled up to a maximum of \$200.00.
- ♦ **Renewal** applications for full liquor licenses, that are required to be connected to a restaurant must show that no less than 60 percent of gross sales from the preceding 12-month operation of a licensed restaurant be derived from food services.


